3. 20' : Handling of containers with gross weight between 32 -35 MT will be 1.10 times of the tariff rate & above 35 MT will be charged 2 times on all activities.
4. 40' : Handling of container with cargo weight between 33-35 MT will be charged 1.10 times on all activities & above 35 MT will be charged 2 times on all activities.
5. Rates indicated for 20Ft also applies for 22 Ft and where rates are indicated for 40Ft also applies for 45Ft.
6. For hazardous/Reefer/Tank containers, an additional 20% will be charged for all activities.
7. For ODC consignments the rates are minimum double of the normal THC and also subject to dimensions.
8. Fuel Surcharge will be subject to diesel price
